July 17th - Plane crash. 15 GH, half of boulder county, Indian Peaks took command. GH sent 2 trucks with 7 people and set up sub command in GH Fire Dept.

Eventually turned over to Boulder County, and then turned over to GH at about 2pm, then turned over to FAA.

July 18th - Smoke report West of the crash - could not see anything. Report was 5 miles west of the crash.

After Action - Thursday, 5:30pm at Boulder County Fire Training Center - Critical stress debriefings.
